

Privacy policy and use of cookies

- 1. This privacy policy defines the rules of processing and protection of personal data provided by users in relation to the use of services offered by the website 4naturesystem.pl (hereafter: Website).
- 2. The Administrator of personal data contained in the Website is SUBITO ADVISING GRZEGORZ DUSZYŃSKI, Wawelberga Street 5A/156, 01-188 Warsaw, entered into the Central Register and Database of Business Activity under the Tax ID number: 8212135140 (hereafter: Administrator).
- 3. Out of concern for the safety of data entrusted, the Administrator operates subject to internal procedures and recommendations, in accordance with the relevant legal acts on the protection of personal data, in particular the Regulation of the European Parliament and the EU Council 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and the free movement of such data, and the repeal of Directive 95/46/EC.
- 4. The Administrator takes the utmost care to protect the interests of data subjects, and in particular, to ensure that personal data is:
 - a) processed legitimately;
 - b) collected for the indicated purposes in accordance with the law, and not subjected to further processing non-compliant with these purposes;
 - c) substantively correct and appropriate to the purposes for which it is processed;
 - d) stored in a form that provides for identification of the data subjects, no longer than necessary to accomplish the purpose of processing.
- 5. Personal data is processed subject to the informed consent of the Website users, and in cases where the existing law authorises the Administrator to process personal data.
- 6. The Administrator processes personal data voluntarily provided by users of the Website, exclusively for the purposes of responding to users queries addressed via the contact form, in the following scope:
 - a) name and surname;
 - b) e-mail address;
 - c) phone number
- 7. Personal data of https://4naturesystem.pl users are not sold or shared with third parties, neither are they subjected to profiling, i.e. automated processing to assess and determine personal traits or needs of users.

- 8. The User of the Website is entitled to access data provided to the Administrator for processing. The User also has the right to modify the data, request it to be forwarded to another entity and limit or stop the processing of his/her personal data at any time. The user may also at any time withdraw previously given consent to the processing of their data and request the removal of their personal data from the website.
- 9. To exercise the rights specified in pt. 8 above, the user of the Website should contact the administrator using the same e-mail address or telephone number provided to the website, by contacting info@wertykalni.pl.
- 10. The Administrator accomplishes the function of obtaining information about users and their behaviours in the following way: a) by voluntarily entering information in the form; b) by collecting "cookies."
- 11. On the first visit to the 4naturesystem.pl website, the user is informed about the use of cookies. By staying on the website, the user accepts the use of ordinary cookies on the website. The lack of changes to the browser settings by the users is tantamount to consenting to the use of "cookies".
- 12. The installation of "cookies" is prerequisite for the proper rendering of services on the Website. "Cookies" contain information necessary for the proper functioning of the website, in particular, those requiring authorisation. The user may at any time change his/her browser settings so that cookies are either accepted or rejected, or so that the user is notified of the failure to store these files on his/her computer.
- 13. The following types of "cookies" are used within the Website:
 - a) session cookies they remain in the browser until closure or log out from the website on which they were stored;
 - b) permanent cookies they remain in the device's Internet browser until the user deletes them; or until the predetermined time specified in the cookies parameter.
- 14. The Website may contain links to other sites that operate independently of the wertykalni.pl website, and are not in any way supervised by the Website. These websites may have their privacy policies and regulations, which we recommend you read carefully.
- 15. The administrator reserves the right to change the website's privacy policy due to the technological development of the Internet, changes in the law regarding personal data protection and development of the Website. Any changes shall be communicated to users in a visible and comprehensible manner.
